In continuation of this office Notification No. 3 of 2012 dated 16.04.2012 the Hon'ble Chancellor, in exercise of the powers vested in him under Section 41 (4) (a) of the Kashmir and Jammu Universities Act, 1969, is pleased to accord his assent to the following Statutes in pursuant to the Resolution No. 71.22 and 71.07 of the 71st University Council at its meeting held on 9th September, 2011 at Raj Bhavan, Srinagar:

- Adoption of Statutes regarding selection procedure for admission in Master's Degree Programme in International Business (MBA-IB); and the Fee Structure (as given in Annexure-I & II) shall be incorporated in Chapter-XVI and Chapter LXXIV, Appendix-III, Rates of Examination and other Fee/Charges for different services of the University Calendar (Vol-II), 2010.
- ii) Amendment of Eligibility criteria for admission of BBA from 45% to 50% for open merit and from 40% to 45% for reserved categories.

Eligibility

The prospective candidate must hold a Bachelor's Degree with at least 50% marks or equivalent CGPA in any discipline from a recognized Indian University or any other equivalent examination with 50% marks. The candidates who have appeared or are appearing in the final year Bachelor's Degree Examination in 2011 or as the case may be, can also apply provisionally. However, such candidates shall have to produce the proof of having appeared and/or passed their Bachelor's Degree Examination with the requisite percentage of marks by the date as may be specified by the University of Jammu.

Selection Procedure

The Course shall be self supporting. The Selection for admission to the Course shall be made on the basis of:

- (a) Common Admission Test (CAT)
- (b) If seats remain vacant the same shall be filled on the basis of Management Aptitude Test (MAT).
- (c) The weightage of the Academic Record.
- (d) Group Discussion and Personal Interview to be conducted by an Admission Committee duly constituted and approved by the Dean Academic Affairs, University of Jammu.

The minimum percentile in CAT and MAT for admission and in the selection procedure would be 50 percentile as in case of Statutes for the General MBA Programme.

No candidate shall be called for Group Discussion and Personal interview unless he/she has passed the Written Entrance Test as mentioned above with at least 50 percentile marks (40 percentile for the candidates belonging the SC/ST). However, if situation so warrants the Vice-Chancellor on the recommendation of the Admission Committee, may lower the qualifying percentile for a session.
