
It is hereby notified that the **75th University Council** at its meeting held on **11th October, 2013** at Raj Bhavan, Srinagar approved the Regulation **75.34** regarding **Modification of the "Financial Powers" governing "Administrative and Financial Powers"** which shall be incorporated in **Chapter-XXXVII-E** of the University Calendar, 2010, **Vol-I**, which reads as under:
